Resolution 2005-1

WHEREAS, the Southeastern Association of Fire Chiefs believes that Fire Sprinklers save lives; and,

WHEREAS, the Southeastern Association of Fire Chiefs believes that additional measures should be taken to protect at risk groups such as senior citizens and youth; and,

WHEREAS, the Southeastern Association of Fire Chiefs urges both Congress and each State Legislature to enact Legislation requiring the retrofitting of sprinklers in all Nursing Homes, Assisted Living Facilities, College Student Housing including Dormitories, Fraternity and Sorority Houses;

THEREFORE, BE IT RESOLVED, the Southeastern Association of Fire Chiefs encourages the support of the International Association of Fire Chiefs to promote the enactment of Legislation requiring the retrofitting of sprinklers in all Nursing Homes, Assisted Living Facilities, and College Student Housing including Dormitories, Fraternity and Sorority Houses.

Resolution 2005-8
